INFORMATION ON THE RESULTS AND SELECTION PROCESS:

The budget available for this selection was 2 M €.

A total of 46 applications were submitted within the call for proposals CNECT/L3/2019/4513255, amongst them 5 applications were ineligible. Therefore, 41 applications were assessed against the award criteria.

Results:

- **5 applications** are proposed for funding
- **1 application** is proposed on the reserve list
- **27 applications** satisfied the pre-announced award criteria, but could not be funded due to lack of budgetary appropriations
- **8 applications** could not be funded because the overall score attributed to these proposals was below the required minimum threshold

Geographical coverage:

Applications were submitted by organisations coming from 17 European countries (coordinators of the projects): IT, FR, HR, NL, ES, SE, RO, PL, BG, CY, LV, CZ, BE, DE, SK, EL, LT. Together with partnering organisations the number of countries amounts to 25,

including additionally: SI, HU, FI, MT, PT, EE, DK and UK. The majority of submitted applications came from Italy (26%) and France (13%), followed by Croatia (10,8%) and The Netherlands (8,6%).

Out of the 5 selected projects, the following countries are represented: Italy, France, Croatia, Bulgaria and Germany (coordinators). 22 partnering organisations of the selected projects will participate in the projects. The majority of partnering organisations come from Italy (5) and Croatia (4), followed by Belgium (2), Germany (2), Netherlands (2), Slovenia (2), UK (1), Hungary (1), Romania (1), France (1) and Greece (1).
